The IHRLC policy advocacy projects have generated research and impact advocacy reports, including on human rights standards concerning pretrial juvenile detention, the persecution of political dissenters and religious minorities by the Vietnamese government, and human rights abuses facing LGBT Afrodescendants in South America.

Outside of the Clinical Program, have taught an Immigration and Nationality Law survey course and seminar class entitled *The Rights of Non-Citizens: The Impact of Citizenship Status on Human & Civil Rights in the U.S.* Also served as a faculty co-director for the Summer Law Program in The Hague.
